## St Mary's Planned Giving

This year it will cost about £285,000 or £5,500 per week, to run our Church and support our activities described in the Annual-Report. We rely on people supporting St Mary's by signing up to give money regularly through our Planned Giving Scheme.

We encourage giving by standing order from your bank as an alternative to the envelopes that you place in the church collection. Income tax payers can help the Church even more through Gift Aid which allows the Church to reclaim the basic rate of income tax already paid by the donor. (If you are a higher rate tax payer you also keep the difference between the two tax rates).
